To receive an AKC medallion award for a quarter-century of service representing the Collie Club of America at the American Kennel Club underscores the significance of such service.

## HIGHLIGHTS FROM THE SEPTEMBER 11, 2012 DELEGATES MEETING AND SEPTEMBER 11-12, 2012 BOARD MEETING

**New York, NY** – Highlights from the September 2012 meetings of the Delegates and AKC Board of Directors are as follows. Full details on these actions, as well as other actions taken, are included in the minutes for the meeting, which are posted on the AKC website, within one week of the meeting.

## **Delegates Meeting**

- AKC announced that effective September 11, 2012, it will award Urban Search and Rescue Titles to dogs that are FEMA certified as deployable on FEMA task forces and to dogs that are certified by States as deployable on State task forces. The first such title was presented to Juno, a FEMA certified English Springer Spaniel owned and handled by Becky Stanevich, Delegate for the Mountaineer Kennel Club.
- An amendment to Chapter 16, Section 1, of the *Rules Applying to Dog Shows* was adopted. Effective January 1, 2013, there will be a new three point major for the dog designated Reserve Winners Dog and Reserve Winners Bitch at one National Specialty each year, specified by the Parent Club, provided there are at least twice the number required for a five point major in the winner's sex. The Parent Club would have the option of not providing the additional major.

- Four Delegates were recognized for twenty-five years of service as a Delegate. They are:
  - o Gretchen Bernardi Mississippi Valley Kennel Club
  - o Charles H. Schaefer Kennel Club of Philadelphia
  - Robert S. Jaggers, Jr. Kern County Kennel Club
  - o Harold W. Sundstrom Collie Club of America
- Four Clubs were honored for one hundred years as an AKC Member Club. They are:
  - American Foxhound Club
  - Bulldog Club of Philadelphia
  - o Middlesex County Kennel Club
  - Pacific Coast Boston Terrier Club

## **Board Meeting**

- The Board voted to forward without recommendation, a Bylaw amendment proposed by the Delegate Advocacy and Advancement Committee to the Delegates for a read at the December 2012 Delegate Meeting for a vote in March 2013. If adopted, it would reduce the number of annual Delegate meetings to three, with an additional day of Delegate Committee meetings at two of those Delegate meetings.
- The AKC established full reciprocity with the National General Kennel Club (NGKC) in China.
- Effective January 1, 2013, eligible clubs will be permitted to hold up to twelve Agility Trials in a calendar year.

# **Community Project for CCA 2013**

We will again be having a community service project for the 2013 National in La Crosse. We will be collecting and distributing children's books to various locations such as schools, libraries and hospitals. We did this in 2008 with stuffed animal toys and it made a great impression on the city. The convention bureau is looking for locations that would like to receive the books along with a visit from a Collie or two.

Towards that end, we are asking all who are coming to La Crosse to bring a book or two along so that we can have a ton of books to pass out to the La Crosse children. Books for all ages are welcome.

A round of applause was given to her tor her fine job of completion for the second time of the Yearbook by the National, saving the Club hundreds of dollars in postage and mailing costs. Hal Sundstrom made a motion that we extend Michelle's term as editor till 2013. Ratification of these motions will be put on the next ballot.

# Updating Report from Judy Guthrie, Show Permssions Committee

Hello All.....I had a very nice talk with Peter of Preisner Pewter, LLC.....I told him of our problems and that I had cups to send back to him...He gave me his UPS account #... I have approximately 16 cups to send back as of this writing. He asked me how they are stored and how they are shipped. I told him they are in my unattached garage - the only place I have for that quantity. That when I ship I do not open but just put the label on the box and take to Federal Express. He was not aware that we were not putting in another box to ship... I informed him that none of the boxes are damaged, that all the damages are internal in nature. . . Pati, you did express a concern to me the other day when we spoke and that was what happens if a club member drops the trophy, damages and then claims that it was received like that. . . I have one trophy -- one of the ones I inspected before shipping, that looks maybe like that. . . can't say for sure, but I would never have shipped a trophy that looked like that. As of this writing, I have 51 cups on hand. I need to replace 3, which will take me down to 48. That many should take me through the end of the year...you never know. Club members are slow this time sending in their paperwork -- I have had to send out a lot of reminder emails and then more follow up after that. . . . Some of my regular Show Chairs are giving up their positions to newbies and they don't know what to do. . .

I plan to take the cases of returns to UPS tomorrow and Peter is to call me after receiving and going over the boxes. . .

# **Updating Report from Online Storage Committee**

The online storage committee would like to request an upgrade to the next level of storage. We currently have 5 GB. At the bare minimum, we need to increase to 10GB to make room for production files for the two publications.

This increase would double our annual costs to \$399 annually or \$39.95 a month.

In the past month, we've seen real success in using the online storage. It has been extremely helpful with collaboration on projects for the Bulletin between staff and also our printer. Online storage has also benefitted the 2008 yearbook because a number of files were archived to online storage last year that proved to be necessary and helpful to complete POS.

Membership came onboard over the last few months. The online Ethics archive, posted by Tom Montero, was transferred to Les Canavan as she assumed the role of Ethics Chairperson.

Over the summer, we set up several committees with access and are hoping to see people embrace and use this especially for critical business files from Membership, the Treasurer and National Show Committee.

Michelle is getting ready to upload a large amount of 2008-2009-2010-2011-2012 yearbook files on the server, so it would be great if we could get this added as a discussion item this next month. I don't want this email, in its entirety, as a discussion item...just the facts that we have an immediate need with the Bulletin and Yearbook to increase our storage space and that the bare minimum would be to double our current capacity of 5 GB.

Michelle has two books in progress that need to be uploaded and 2 completed books that need final files loaded. The bulletin has two editions of final files that need to be uploaded.

Susan Larson has pictures that Pati has requested to be saved for archives and we need to leverage the online storage for the Library of Champions.

# **AKC's Criterion for the Award**

## Good Sportsmanship Award......

Thought it might be a good idea to insert for your review the standard recommended by the AKC for this award.

The AKC states that this award is their way of helping clubs recognize and celebrate the efforts to their volunteer club members. The AKC Outstanding Sportsmanship Award program is provided to each member club with an AKC Medallion to award to one of its own on a yearly basis.

This award honors those individuals who deserve special recognition that have made a difference in the sport of purebred dogs, embodied the AKC Code of Sportsmanship, and have been an active and valued member of an AKC member club. Medallions are awarded solely at the club's discretion.

## AKC Code of Sportsmanship

PREFACE: The sport of purebred dog competitive events dates prior to 1884, the year of AKC's birth. Shared values of those involved in the sport include principles of sportsmanship.

They are practiced in all sectors of our sport: conformation, performance and companion. Many believe that these principles of sportsmanship are the prime reason why our sport has thrived for over one hundred years. With the belief that it is useful to periodically articulate the fundamentals

of our sport, this code is presented.

• Sportsmen respect the history, traditions and integrity of the sport of purebred dogs.

• Sportsmen commit themselves to values of fair play, honesty, courtesy, and vigorous competition, as well as winning and losing with grace.

• Sportsmen refuse to compromise their commitment and obligation to the sport of purebred dogs by injecting personal advantage or consideration into their decisions or behavior.

• The sportsman judge judges only on the merits of the dogs and considers no other factors.

• The sportsman judge or exhibitor accepts constructive criticism.

• The sportsman exhibitor declines to enter or exhibit under a judge where it might reasonably appear that the judge's placements could be based on something other than the merits of the dogs.

• The sportsman exhibitor refuses to compromise the impartiality of a judge.

• The sportsman respects the AKC bylaws, rules, regulations and policies governing the sport of purebred dogs.

• Sportsmen find that vigorous competition and civility are not inconsistent and are able to appreciate the merit of their competition and the effort of competitors.

• Sportsmen welcome, encourage and support newcomers to the sport.

• Sportsmen will deal fairly with all those who trade with them.

• Sportsmen are willing to share honest and open appraisals of both the strengths and weaknesses of their breeding stock.

- Sportsmen spurn any opportunity to take personal advantage of positions offered or bestowed upon them.
- Sportsmen always consider as paramount the welfare of their dog.

• Sportsmen refuse to embarrass the sport, the American Kennel Club, or themselves while taking part in the sport.
