#### Location of trial site: Keepstone Farm, 412 Russell Road, Berryville, Virginia 22611-2326

Briefly describe the trial site and note other herding events held there:

Numerous arenas are available, including 100' x 100', 100' x 50' duck arena, 200' x 100' PT arena, 155' x 255' A course arena and a 20 acre B course. There are separate fields/arenas set up for AHBA HTAD, HTD, and HRD events. The Chesapeake Cardigan Welsh Corgi Club holds an annual trial, the Shetland Sheepdog Club of Greater Baltimore holds at least one trial and frequently two. The Belgian Sheepdog Club held their herding National at Keepstone in 2009. During the year, there are quarterly AHBA trials – and in 2011, there was an AHBA trial over Thanksgiving with turkey classes. Several new clubs will be holding their first trial and/or herding instinct test this year.
