It shall be the duty of the Delegate to attend the meetings of the American Kennel Club and represent the Club in accordance with the instructions of the Board of Directors; to perform such other duties as are incident to the office as prescribed by the Constitution and Bylaws of The American Kennel Club and to report to the Board of Directors and the membership, through the Secretary after each meeting of The American Kennel Club.

3. The President presents for discussion the bid proposal from Collie Expressions for the CCA 2014 Calendar.

4. The President presents for discussion the continuation of the CCA Calendar for our future.

5. The President presents for discussion Tom Coen to represent the CCA in the list of Herding presenters. The AKC/Judging Operations Department and co-hosted with the Dog Judges Association of America is for the second consecutive year offering Advanced Judging Institute in conjunction with the AKC/Eukanuba National Championship and the Florida Classic Show in Orlando FL, December 11-14, 2014. This year's event features presenters from Hound and Herding Groups. The CCA Judges Education Committee has submitted the name of Tom Coen to represent the Collie and the CCA at this event and the President is presenting his name along with a budget of \$500 to cover expenses.

6. The President presents for discussion the following event: The CCA has been sent the the invitation to offer a Meet the Breeds booth at the AKC/Eukanuba National Championship and the Florida Classic Show in Orlando FL, December 11-14, 2014. The President has contacted Paula Clairday who has offered to host chair the event again to represent the CCA and its activities. This event includes the cost to the CCA for electricity of \$110 for the weekend. Letter from the AKC is included for you full information within the Communique'.

7. If the above event participation is approved, the following will be offered by the CCA. Medallions: Conformation \$125 (special rate of \$100 per variety – 5 medallions), Obedience \$45 – 1 medallion, and Agility \$45-1 medallion. Notification to the AKC must conformation medallions is August 1; therefore, if agreement is meet by the Board, the officers will vote to approve with ratification for this action to follow with ratification by the Board in the following communique'.
