I would ask that you give the committee your thoughts and work together to make the necessary changes to meet NYS law requirements. **Again I must Stress, this is a work in progress.** 

I will be in touch with you to set up times to hold the meetings with the Constitution Committee. Please make time in your schedule to attend.

Richard Greathouse MD,

Dr. Richard F. Greathouse passed away on Wednesday evening, October 7, 2015. He was past-President of the Collie Club of America and an All-Breed judge licensed for the Herding Group, Working Group, Terrier Group, Hound Group and Best in Show. He was a retired physician and long-time pediatrician in private practice in Louisville, Kentucky. He held public office as the Jefferson County and subsequently Metropolitan Louisville Coroner from 1974 through 2002. He was a very popular public figure and consistently the top vote-getter for the Democratic Party for over 28 years. He was often called upon to treat ailing celebrities including Frank Sinatra and many others, who appeared in town. In 1991, Dr. Greathouse spearheaded the exhumation of the body of President Zachary Taylor to prove that he was not poisoned (<a href="http://www.c-span.org/video/?124351-1/exhumation-zachary-taylor">http://www.c-span.org/video/?124351-1/exhumation-zachary-taylor</a>). Doc was a true character with a wonderful sense of humor, but always a gentleman. He remained close to his Collie friends including Sally & Bob Futh, June Morris, Diane Steele, Linda Ayers Turner Knorr and many more, over the years. He was my pediatrician when I was a kid and always took the time to sit ringside with me once I started judging to mentor me in multiple breeds. He never met a stranger. Doc was a strong animal-rights advocate and horse racing enthusiast. He enjoyed his time at the racetrack and truly loved the Collie breed. He owned many Collie greats including Ch. Lewellen Cali-Collaire and his homebred, Ch. Devonshire Dark Cheri who was Winner's Bitch at the Collie Club of America National Specialty in 1960 in Kansas City. Dr. Greathouse was cremated at his personal request. The family is planning a Memorial Service for a later date.

The 2015 National, Follow That Dream, was a wonderful and enjoyable show at a new downtown site in Oklahoma City, OK. The show Co-Chair, Roxann Heit, and her show committee did a stunning job in providing everyone with a very nice National experience. The dogs looked great, seminars were awesome and seeing old friends and meeting new friends was fun.

The financial results for this National were, I am sorry to say, poor. Net, the show in total lost over \$18,345. The expenses were generally in line with the 2014 national (\$122k in 2014 vs. \$118k in 2015) but the income (\$123k in 2014 vs. \$100k in 2015) was significantly lower. The Conformation/Obedience/Rally events, Herding events and Agility events all had losses of \$14,794, \$1,121 and \$2,430, respectively.

The key income drivers that drove the miss include: catalog advertising and sales of \$6,830 in 2015 vs. \$10,849 in 2014, agility entries of \$3,150 in 2015 vs. \$7,067 in 2014, obedience and rally entries of \$5,530 in 2015 vs. \$8,950 in 2014, and reserved grooming reservations of \$15,420 in 2015 vs. \$19,119 in 2014. Offsetting these numbers were trophy donations of \$15,609 in 2015 vs. \$13,489 in 2014 and herding entries of \$5,835 in 2015 vs. \$2,700 in 2014. Surprisingly, conformation entries were essentially flat year over year (\$21,230 in 2015 vs. \$22,649 in 2014) as were vendors (\$3,820 in 2015 vs. \$3,475 in 2014), state baskets (\$1,345 in 2015 vs. \$1,425 in 2014), and merchandise income (9,452 in 2015 vs. \$9,741).

The key expense drivers that drove the miss include: site rental costs of \$34,850 in 2015 vs. \$23,800 in 2014, merchandise of \$8,995 in 2015 and \$5,828 in 2014 and trophy/ribbons/rosette costs of \$18,171 in 2015 vs. \$11,062 in 2014.

In summary, I would point to three major controllable issues that we need to manage better for future Nationals: the cost of the site and the profit margins on merchandise and trophies.

It was obvious the show committee put in a lot of time and effort to organize the show & support the many events during the show event. Show Chair Roxann Heit stepped in to run the show with the passing of Sylvie Lingenfelter. In my opinion, money aside, she and her team did a fine job and provided everyone with a wonderful and friendly experience.

They have been my sounding board, my sunshine when clouds roll in, and always fuel my desire to learn more. I attend as many specialties as I can and I am not too shy to ask people to show me the finer nuances of this beautiful breed. I enjoy listening to the long-term breeders discuss the greats from the past and to tell of the wonderful virtues these dogs possessed.

I am honored to be asked to join the Breed Education Committee as in intern. I will bring the eyes of a newer collie lover to this group. I will work diligently and cooperatively, in the spirit of protecting this breed that is so dear to us all, in hopes that we leave the collie better for many generations to come.

- 1. Candidate name submissions should come via a Board member.
- 2. The number of candidates is not limited to one candidate per Director.
- 3. Please Directors limit the recommendations to three per candidate when you submit those names to the Secretary and the recommendation must accompany the name submission.
- 4. Please limit the recommendation to 100 words or less.
- 5. Directors, the selected candidate for AKC Good Sportsmanship Award candidate for 2016, will have a booklet prepared to go along with the award and certificate presentation containing all letters written of support and nomination of the candidate. Upon the selection, the Committee will contact the person making the nominee, to help with providing materials such as photos for the booklet.

#### **AKC's Criterion for the Award**

#### **Good Sportsmanship Award.....**

Thought it might be a good idea to insert for your review the standard recommended by the AKC for this award. The AKC states that this award is their way of helping clubs recognize and celebrate the efforts to their volunteer club members. The AKC Outstanding Sportsmanship Award program is provided to each member club with an AKC Medallion to award to one of its own on a yearly basis.

This award honors those individuals who deserve special recognition that have made a difference in the sport of purebred dogs, embodied the AKC Code of Sportsmanship, and have been an active and valued member of an AKC member club. Medallions are awarded solely at the club's discretion.

#### **AKC Code of Sportsmanship**

PREFACE: The sport of purebred dog competitive events dates prior to 1884, the year of AKC's birth. Shared values of those involved in the sport include principles of sportsmanship.

They are practiced in all sectors of our sport: conformation, performance and companion. Many believe that these principles of sportsmanship are the prime reason why our sport has thrived for over one hundred years. With the belief that it is useful to periodically articulate the fundamentals of our sport, this code is presented.

- Sportsmen respect the history, traditions and integrity of the sport of purebred dogs.
- Sportsmen commit themselves to values of fair play, honesty, courtesy, and vigorous competition, as well as winning and losing with grace.
- Sportsmen refuse to compromise their commitment and obligation to the sport of purebred dogs by injecting personal advantage or consideration into their decisions or behavior.

- The sportsman judge judges only on the merits of the dogs and considers no other factors.
- The sportsman judge or exhibitor accepts constructive criticism.
- The sportsman exhibitor declines to enter or exhibit under a judge where it might reasonably appear that the judge's placements could be based on something other than the merits of the dogs.
- The sportsman exhibitor refuses to compromise the impartiality of a judge.
- The sportsman respects the AKC bylaws, rules, regulations and policies governing the sport of purebred dogs.
- Sportsmen find that vigorous competition and civility are not inconsistent and are able to appreciate the merit of their competition and the effort of competitors.
- Sportsmen welcome, encourage and support newcomers to the sport.
- Sportsmen will deal fairly with all those who trade with them.
- Sportsmen are willing to share honest and open appraisals of both the strengths and weaknesses of their breeding stock.
- Sportsmen spurn any opportunity to take personal advantage of positions offered or bestowed upon them.
- Sportsmen always consider as paramount the welfare of their dog.
- Sportsmen refuse to embarrass the sport, the American Kennel Club, or themselves while taking part in the sport.

The President stated this concludes the voting. Then, the meeting was opened for discussion. The President began with reiterating that he had requested a side by side comparison of the proposed Constitution and By-laws to be done by the Constitution Committee to help the club understand the specific changes required by NYCL for the CCA Constitution and By-Laws. He is expecting this to be presented to the Board by next week.

The Board discussed the usage of Constant Contact in regards to the types of communications and identifying who has authorization to send them. There was agreement among the directors including Sue Kuechenmeister and Linda Mabus.

It was also brought up for clarification that the districts/realignment in the new Constitution/By-Laws would be 10 districts and 10 district directors, one director from each district.

The President mentioned again the need for the usage of Committee Chairs and Board members regarding our Online Storage as reported to him by Laura DeLaurentis.
