Tuesday, March 23 – 12:00 noon to 9:00 pm Drive through Gate 1/Service Gate A (proceed to the north end of Building 4): Wednesday, March 24th through Saturday, March 27th – 6:00 am to 8:00 am. All vehicles must be removed from the grounds by 8am.

Parking:

If you are a guest at the Sheraton Suites, you will park in the Sheraton Parking lot and enter the grounds through the Red Gate at the back of the hotel. Bldg 4 is just inside the Red Gate.
