Terms and Conditions

The Collie Club of America (CCA) National Specialty Show will be held at Cal Expo, 1600 Exposition Blvd., Sacramento, CA 95815 from March 22 – 25, 2017.

Concession space is available first to long-term, regular vendors and then on a **first come, first served** basis to all vendors of dog related products and services. Space is offered for all four days of the show, in 10 x 10 blocks at a rate of \$200.00 per space for vendors who are CCA members and \$300.00 per space for non-members. Additional 10 x 10 blocks will be available, on a limited basis, for vendors needing larger booth spaces, each additional 10 x 10 block will be at the rate of \$100.00 for CCA members and \$150.00 for non-members. One 8 ft. table and two chairs are included. Show Committee reserves the right to limit size and number of spaces. There will be no additional charge for electricity. Additional tables can be rented for \$15.00 each, extra chairs for \$4.00 each. All booth space, need for electricity, extra tables and/or chairs must be specified on this contract and paid for with reservation. Please make sure you have grounded extension cords and duct tape if you need electricity.

No sharing of space is allowed unless specified on this Contract. The name and full contact information of each vendor sharing the same space must be provided and the products/services of each must be specified. You may not allow an extra person or vendor to share your space once you are at the show.

The site is available for set up on Tuesday, March 21, 2017 at 10:00am. All merchandise and equipment must be removed from the site no later than noon Sunday March 26, 2017.

Need for electricity must be specified with this agreement, otherwise there is no guarantee that it can be made available. The CCA will do its best to see that all are accommodated within the limits of availability within the site.

Vendors shall be responsible for the collection, reporting and payment of California State Sales Tax. A form for this will be given to you at the beginning of the show and you are expected to collect sales tax on your sales, then report it on the form provided and send in with payment to the State of California. The Collie Club of America obtains a blanket sales tax license from the State Tax Commission and each vendor is responsible for collecting, reporting and payment.

Each vendor is encouraged to make a merchandise donation to the Collie Club of America, Collie Health Foundation, Collie Rescue League or Junior's to be used for raffles. Donations can be collected at the show.

Vendors shall be responsible for the safety and security of their merchandise. There will be hours when the building is locked. The CCA, Cal Expo and the City of Sacramento, CA shall be held harmless in the event of loss or theft.

The CCA show committee reserves any and all rights to the exclusive logo of the show. This specifically means that no vendor shall be permitted to offer for sale any items of merchandise which utilize the artwork of the show logo or CCA unless they have received authorization from the host show chairman.
